MANDATORY OR OPTIONAL NATURE OF THE PROVIDING OF DATA. We inform you that, taking into account the purposes of the processing as illustrated above, the provision of data is mandatory and their failure, partial or incorrect, could result in the failure to finalize the contract.

LODGING A COMPLAINT WITH THE SUPERVISORY AUTHORITY. The data subject is entitled to lodge a complaint with the Supervisory Authority (Italy: Garante per la protezione dei dati personali www.garanteprivacy.it).

RIGHTS OF THE DATA SUBJECTS. It is possible at any time, to exercise the rights to access personal data, rectify or erase the latter, restrict processing, object thereto or to processing portability according to articles 15-20 of European Regulation 679/2016 by sending an e-mail to the following address: info@fnacompressors.com

The exercise of the rights of the data subjects may be delayed, limited or excluded in the cases provided for by art. 2-undecies Legislative Decree 196/03.
